Hi Rolf:

There have been some very minor updates to the information since the last update on when/how the patient was contacted on the re-test results –we estimate these changes at about 1% of what was previously provided. However, we are expecting a set of data from Eastern on Friday (tomorrow) that has major updates to:

contact information for patients currently in the database
information on the DCIS patients (N=52)
information on the “no tumors”
information on approximately 12 positives who called in and requested that they be retested

Perhaps Sandy may wish to wait until this data is received and entered?
