Robert – I have look into this and have determined that on May 1st 2008, the Centre had provided Eastern with the most current contact information for individuals in the ER/PR database through the provincial Client Registry. Note that the Client Registry has a direct link to the MCP Database and as such would include updated contact information provided through the MCP re-registration process. Tracey reported that all 1020 patients that were considered for communication analysis had the address information provided through this linkage to the Client Registry. There are 1035 unique individuals in the database, but the address information was not provided for 15 patients because they did not have an original test done in NL and therefore addresses were not required.
