I have received a consult report on Mrs [REDACTED] RS- [REDACTED] (Western Health Corp. # [REDACTED] and Dr. Mullen confirmed his diagnosis (as in a spread sheet) of a small focus of Invasive Ductal carcinoma seen on one glass slide, labelled #2 using immunohistochemical stains.
